Payment Terms:

1. We will issue a final account within ten days from the date of the funeral service.
2. Part payment of the total estimate, i.e. Cemetery/Cremation fees paper notices, floral tributes etc (*disbursements*) before the service would be appreciated.
3. An Administration Fee is charged to the final account. This can be deducted if payment is made in the time frame stated on the final account.
4. If you have not paid the account by 60 days from the date of the funeral service, we may take steps to recover the amount unpaid and you will be liable for any additional cost of any collection fees applicable.
5. The estimated price provided to you in this agreement has been given in good faith but is not binding on us. Our price will be the total price plus any additional charges incurred by us (including any government charges or taxes) in providing the services outlined in this funeral agreement.
6. All prices are inclusive of Goods and Services Tax (GST)
